

- (6) The used generator must be returned to the supplier
- (7) This product must only be used by persons suitably trained and competent to carry out this work
- (8) Operators must refer to the Health and Safety Commission's Approved Code of Practice on 'The Control of Substances Hazardous to Health in Fumigation Operations' (ref. L86) and the associated HSE guidance Note on 'Fumigation' (ref. CS22) before using this product.
- (9) This product must only be used in storage rooms with a minimum volume of 100 cubic metres.
